**ELIMINATION AND/OR REDUCTION OF
CONFIDENTIAL/ADMINISTRATOR EMPLOYEE SERVICES**

WHEREAS, Education Code sections 45117 and 45308 provide that confidential and administrator employees shall be subject to layoff for lack of work or lack of funds and be informed of their displacement rights, and reemployment rights if any per 45298; and

WHEREAS, Education Code section 44951 provides that administrator employees subject to layoff shall be given notice of reassignment not later than March 15th and be informed of their displacement rights, if any, and reemployment rights per 44955 and 44956; and

WHEREAS, the Board of Trustees of the Hollister School District hereby finds that budgetary considerations for the 2022-2023 school year require administrator and confidential employee services be eliminated due to lack of work or lack of funds.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Hollister School District that the certain positions in the confidential and administrator services shall be eliminated for lack of work and/or lack of funds, as follows:

1. Migrant Coordinator	.55 FTE
2. Special Education Coordinator	1.0 FTE
3. Assistant Principals	2.0 FTE
4. HR Analyst	1.0 FTE

BE IT FURTHER RESOLVED by the Board of Trustees of the Hollister School District, as follows:

1. The Superintendent or her designee is directed and authorized to give notice of layoff to the affected confidential and administrator employee(s) in accordance with the requirements of law; and
2. Said layoff and/or reductions in hours shall become effective no later than June 30, 2022; and
3. That confidential and administrator employees laid-off pursuant to this Resolution shall be eligible for reemployment in accordance with Education Code section 45298 and 44956.
