WHEREAS, the Hollister School District offers all students support through base and supplemental programs which allow for student instruction to take place, district-wide and;

WHEREAS, the Hollister School District and the Board of Trustees have identified the following as part of base program, per school site: one (1) principal, one (1) office manager, one (1) district nurse, one (1) lead custodian, custodian, one (1) yard supervisor, classroom teachers to meet enrollment requirements and;

WHEREAS, the Hollister School District and the Board of Trustees have identified the following as supplemental to the base program: assistant principals, intervention teachers, English Language Development (ELD) teachers, school secretaries, health office clerks, library media specialists, campus monitors, and yard supervisors beyond the allocation of one (1) yard supervisor, and:

NOW, THEREFORE, BE IT RESOLVED, that the Board of Trustees and the Hollister School District, hereby commits to the following programs as base programs:
